- Requests for higher placement (without skipping content) will be reviewed by the school based review team. The parent / guardian has the right to participate in this process.
- When the request is approved, the student should be prepared to stay in their new placement for the full school year. A class change later in the school year may require additional changes to the class schedule.
- Students are not permitted to transfer out of NC Math 1 after the 20th day in a year-long class due to state policy.
- Requests for waivers for current fifth graders (rising sixth graders) are to be initially reviewed and signed by the elementary school principal. This initial recommendation will then be sent to the middle school principal for final placement.
- According to [HB986](#), students who score a Level 5 on the EOG must be placed in an advanced math course. A parent or guardian will need to provide written consent for the student to be excluded or removed from that course.
